 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "Green Ribbon Act of
- 5 2023".
- 6 SEC. 2. GREEN RIBBON SCHOOLS PROGRAM.
- 7 (a) Definitions.—In this section:

1	(1) ESEA DEFINITIONS.—The terms "elemen-
2	tary school", "local educational agency", "secondary
3	school", "Secretary", and "State educational agen-
4	cy" have the meanings given the terms in section
5	8101 of the Elementary and Secondary Education
6	Act of 1965 (20 U.S.C. 7801).
7	(2) ELIGIBLE ENTITY.—The term "eligible enti-
8	ty' means an elementary school, secondary school,
9	school funded or operated by the Bureau of Indian
10	Education, local educational agency, or institution of
11	higher education.
12	(3) Environmentally literate.—The term
13	"environmentally literate", when used with respect
14	to an individual, means the capacity to—
15	(A) perceive and interpret the relative
16	health of environmental systems and the inter-
17	relationships between natural, economic, and
18	social systems and technology; and
19	(B) assess options and take appropriate
20	action to maintain, restore, or improve the
21	health of the environmental systems and pro-
22	mote sustainable development.
23	(4) Green Ribbon Pillars.—The term
24	"Green Ribbon pillars" means the following 3 inter-
25	related aspirational goals:

1	(A) 100 percent of the graduates of the eli-
2	gible entity or the schools served by the eligible
3	entity are environmentally literate.
4	(B) The environmental impacts of the eli-
5	gible entity's buildings, grounds, and operations
6	are targeting significant emission reductions
7	with a long-term goal of 100 percent reduction.
8	(C) The eligible entity has a net positive
9	impact on the environmental health of its stu-
10	dents and staff.
11	(5) Green Ribbon School Award Winner.—
12	The term "Green Ribbon School award winner"
13	means an eligible entity that has received an award
14	of recognition from the Department of Education for
15	high performance in making progress toward all 3 of
16	the Green Ribbon pillars, in accordance with sub-
17	section $(b)(4)$.
18	(6) Institution of Higher Education.—The
19	term "institution of higher education" has the
20	meaning given the term in section 101 of the Higher
21	Education Act of 1965 (20 U.S.C. 1001).
22	(b) Green Ribbon School Program of the De-
23	PARTMENT OF EDUCATION.—
24	(1) IN GENERAL.—The Secretary shall conduct
25	a program, which shall be known as the "Green Rib-

1	bon Schools Program", to reach and engage more
2	schools by—
3	(A) encouraging eligible entities to imple-
4	ment the Green Ribbon pillars;
5	(B) recognizing high performance in the
6	Green Ribbon pillars by eligible entities,
7	through voluntary partnership with States;
8	(C) increasing the number of participating
9	local educational agencies and schools that are
10	receiving resources from the program, including
11	those not pursuing an award on the date of en-
12	actment of this Act;
13	(D) engaging with public and private
14	stakeholders to maximize positive impact; and
15	(E) supporting schools in implementing
16	measures to reduce energy and water use and
17	costs, increase resilience, and improve condi-
18	tions for health and wellness.
19	(2) Grants and Awards.—In conducting the
20	Green Ribbon Schools Program, the Secretary shall,
21	from the amounts made available to carry out this
22	Act—
23	(A) reserve not less than \$250,000 for the
24	Secretary of Interior to carry out the activities
25	under subsection (c)(6) with respect to schools

1	operated or funded by the Bureau of Indian
2	Education;
3	(B) award grants to State educational
4	agencies under subsection (c); and
5	(C) provide an honorarium to each Green
6	Ribbon School award winner in an amount
7	equal to \$10,000, subject to appropriations.
8	(3) Studies, research, and surveys.—The
9	Secretary may conduct studies, research, and sur-
10	veys to inform the Green Ribbon Schools Program.
11	(4) Green Ribbon School Awards.—Each
12	year, regardless of whether funds are available for
13	the honoraria described in paragraph (2)(C), the
14	Secretary shall—
15	(A) establish a process through which—
16	(i) State educational agencies may
17	nominate eligible entities for recognition of
18	high performance in making progress to-
19	ward all 3 of the Green Ribbon pillars; and
20	(ii) the Secretary of the Interior, oper-
21	ating through the Bureau of Indian Edu-
22	cation, may nominate eligible entities that
23	are schools operated or funded by the Bu-
24	reau for such recognition; and

1	(B) award the Green Ribbon School award
2	to nominated eligible entities that the Secretary
3	determines have shown high performance in
4	making progress toward all 3 of the Green Rib-
5	bon pillars.
6	(5) Reports.—
7	(A) ANNUAL REPORTS.—
8	(i) In general.—Not later than No-
9	vember 1, 2023, and annually thereafter,
10	the Secretary shall publish a report de-
11	scribing the Green Ribbon Schools Pro-
12	gram of the prior fiscal year.
13	(ii) Content of Annual Re-
14	PORTS.—Each annual report described in
15	clause (i) shall—
16	(I) describe the activities and
17	outcomes of the Department of Edu-
18	cation and State grant award winners,
19	including the uses of grant funds to
20	reach and engage additional schools,
21	and the successes and challenges of
22	the Green Ribbon Schools Program;
23	and
24	(II) provide a proposed plan for
25	the following year.

1	(B) BIANNUAL REPORTS.—Not later than
2	November 1, 2024, and biannually thereafter,
3	the Secretary shall publish a report describing
4	key programs and policies of each State in sup-
5	porting its schools in making progress toward
6	all 3 of the Green Ribbon pillars.
7	(e) State Grant Program.—
8	(1) In General.—The Secretary shall award
9	grants to State educational agencies, on a competi-
10	tive basis, for the purpose of supporting and engag-
11	ing eligible entities as green schools.
12	(2) Applications.—A State educational agen-
13	cy that desires to receive a grant under this sub-
14	section shall submit an application to the Secretary
15	at such time, in such manner, and accompanied by
16	such information as the Secretary may require, in-
17	cluding an assurance that the agency will—
18	(A) expend not less than 40 percent of the
19	grant funds to support underresourced schools;
20	and
21	(B) provide documentation to the Sec-
22	retary demonstrating compliance with the re-
23	quirement under subparagraph (A).
24	(3) Criteria.—In selecting grant recipients
25	under this subsection, the Secretary shall consider

1	the State educational agency's proposed program or
2	program expansion in terms of—
3	(A) the projected impact and proposed im-
4	pact metrics;
5	(B) the incorporation of specific activities
6	to ensure underresourced eligible entities ben-
7	efit and have opportunities to participate;
8	(C) the extent to which stakeholders and
9	partnerships are included;
10	(D) innovative approaches to scaling green
11	school practices and learning;
12	(E) the engagement of past award winners
13	in the program, including as mentors or advi-
14	sors to other eligible entities; and
15	(F) other criteria as may be identified by
16	the Secretary.
17	(4) Amount of grants.—In carrying out this
18	subsection, the Secretary may determine the amount
19	of each grant award, except that no grant award
20	shall be for an amount that is less than \$250,000
21	nor more than \$1,000,000.
22	(5) Time Period.—Grant funds awarded under
23	this subsection shall be available for use by the
24	grant awardee for not more than 3 years.

1	(6) Allowed Uses.—A State educational
2	agency that receives a grant under this subsection
3	shall use the grant funds to increase and support eli-
4	gible entities in becoming Green Ribbon School
5	award winners, including by—
6	(A) establishing State-level Green Ribbon
7	awards and recognition events;
8	(B) working in partnership with nonprofit
9	green school organizations and other organiza-
10	tions, utilities, businesses, and other State and
11	local governmental entities to inform, educate,
12	and support eligible entities regarding actions
13	to make progress toward all 3 of the Green Rib-
14	bon pillars;
15	(C) using resources from the Department
16	of Education and its green schools partners, as
17	appropriate, to curate and disseminate re-
18	sources about best green school practices and
19	provide statewide training and professional de-
20	velopment in the Green Ribbon pillars;
21	(D) utilizing innovative ways to promote—
22	(i) the implementation of green school
23	practices; and

1	(ii) the Green Ribbon Schools Pro-
2	gram and any State-level Green Ribbon
3	schools program; and
4	(E) providing statewide training and pro-
5	fessional development in the Green Ribbon pil-
6	lars.
7	SEC. 3. INSTITUTE OF MUSEUM AND LIBRARY SERVICES
8	GREEN RIBBON AWARD PROGRAM.
9	(a) Purpose.—The purpose of this section is to de-
10	velop and implement a Green Ribbon award program for
11	nonformal learning institutions at the Institute of Museum
12	and Library Services in order to recognize and help ad-
13	vance excellence in the greening of nonformal learning in-
14	stitutions.
15	(b) Definition.—In this section, the term "non-
16	formal learning institutions" includes public and private
17	libraries, museums, arboretums, botanical gardens, nature
18	centers, historical societies, historic preservation organiza-
19	tions, history museums, science and technology centers,
20	planetariums, children's museums, art museums, general
21	museums, natural history museums, natural science muse-
22	ums, zoos, aquariums, and wildlife conservation centers.
23	(c) Establishment.—Consistent with section 209
24	of the Museum and Library Services Act (20 U.S.C.
25	9107), the Director of the Institute of Museum and Li-

- 1 brary Services shall establish an award program for non-
- 2 formal learning institutions modeled on the Department
- 3 of Education's Green Ribbon Schools Program. The award
- 4 program shall recognize and honor nonformal learning in-
- 5 stitutions that demonstrate high achievement in all 3 of
- 6 the following goals:
- 7 (1) Ensuring that their visitors are exposed 8 through multiple learning modes to locally relevant 9 information to advance understanding of the inter-
- 10 connection of the natural environment, built environ-
- ment, and quality of life.
- 12 (2) Significantly reducing their net environ-
- mental and carbon footprints, while using their own
- built and natural environment as a learning labora-
- tory and a model of best practice for their host com-
- munity.
- 17 (3) Ensuring their institution has a net positive
- environmental impact on visitor and staff health.
- 19 (d) AWARD.—The Director of the Institute of Mu-
- 20 seum and Library Services shall provide each national
- 21 award winner under this section with an honorarium of
- 22 \$10,000.
