Dear Honorable Senators:

I write as the President of the Association of the Federal Bar of New Jersey to express the Association's strong support for the confirmation of Zahid R. Quraishi to serve as a United States District Judge for the District of New Jersey.

Zahid N. Quraishi began serving as a Magistrate Judge for the District in June of 2019. Before his selection as a Magistrate Judge, he served in private practice at the Riker Danzig firm where he was the chair of the White Collar Criminal Defense and Investigations Group. He also served as the Chief Diversity Officer for the firm. Before his work in private practice, Magistrate Judge Quraishi served as an Assistant United States Attorney in the District of New Jersey and prior to that, he served as an Assistant Chief Counsel with the Department of Homeland Security. Magistrate Judge Quraishi also served honorably in the United States Army Judge Advocate General's Corps. Magistrate Judge Quraishi has had the opportunity to practice both criminal and civil law in the District of New Jersey. His experience on the bench, and before his appointment as a Magistrate Judge, makes him uniquely qualified to fill this critical vacancy in the District of New Jersey.

Magistrate Judges in the District of New Jersey play a critical role in the day-to-day management of litigation matters. On the civil side, they address the full spectrum of non-dispositive issues before the court including, case management, discovery disputes, and alternative dispute resolution. Magistrate Judges also handle an array of criminal proceedings, including initial appearances and bail hearings. As such, serving as a Magistrate Judge in the District of New Jersey is a position that comes with significant responsibility and experience.

Since the time that Magistrate Judge Quraishi took the bench, he has deftly implemented a practical and thoughtful approach to the management of litigation before the Court. In light of the significant caseload shouldered by the judges in this District, the bench is in need of efficient, fair, and practical jurists who can ensure that the objectives set forth in Rule 1 of the Federal Rules of Civil Procedure, which aspire to provide "just, speedy, and inexpensive determination" of proceedings, are met.
