The SHINE for Autumn Act is the next step in preventing stillbirth by helping create long-term solutions and cultivating a greater focus on preventing stillbirths through enhanced data collection, analysis, reporting, and research. March of Dimes looks forward to working with the Senate to ensure this bipartisan bill becomes law.”

“With 24,000 families continuing to experience stillbirth every year across the United States, we need better support, awareness, and resources to support our country’s mothers, birthing people, and families for all pregnancy outcomes,” **said Christy Turlington Burns, Founder of Every Mother Counts.** “Every Mother Counts supports the SHINE for Autumn Act that takes much needed action to increase awareness and education for birthing people and families, improve data collection, and expand resources to help address preventable stillbirth in the United States.”

“Central Jersey Family Health Consortium is proud to sponsor the SHINE for Autumn Act knowing the number of lives it will touch and the potential impact it will have on families during the childbirth period,” **said Robyn D’Oria, Chief Executive Officer of Central Jersey Family Health Consortium.** “In the US, over 21,000 pregnancies resulted in a stillbirth in 2019. While this number is a slight decrease from 2018, significant disparities still exist with non-Hispanic black and non-Hispanic native Hawaiian/other Pacific islander having nearly 2x the rate of stillbirth compared to their non-Hispanic white and Hispanic counterparts. The need for education and research into the causes of stillbirth and why these disparities occur is critical if we are to decrease the incidence of stillbirth in this country. We applaud Senators Booker and Rubio for sponsoring this bill and bringing the needs of parents who experience stillbirth to the forefront as we try to decrease the incidence of this devastating event to families.”

“No family should have to experience the terrible grief and pain that comes with losing a life through stillbirth, but too many families do – and as is the case with so many health issues in our country, there are appalling racial disparities,” **said Tina Sherman, Senior Campaign Director for Maternal Justice at MomsRising.** “That’s why we are so grateful to U.S. Senators Cory Booker (D-NJ) and Marco Rubio (R-Florida) for introducing and championing the SHINE for Autumn Act.”

“The SHINE for Autumn Act is an important step towards preventing stillbirths and promoting positive health outcomes for birthing people and their babies,” **said Terrance Moore, Chief Executive Officer of the Association of Maternal & Child Health Programs (AMCHP).** “Over 20,000 babies are stillborn in the United States every year. Stark racial inequities exist with Black birthing people twice as likely to experience stillbirth as white birthing people. These statistics represent a staggering degree of devastation and loss for every family affected by stillbirth. And yet, stillbirth is a topic so rarely discussed and a public health issue that lacks significant federal investment. The SHINE for Autumn Act lays the foundation for better understanding why stillbirths occur and identifying strategies for preventing stillbirths in the future. As a national organization representing state leaders in public health dedicated to improving maternal and child health, AMCHP is proud to support the SHINE for Autumn Act and grateful to Senator Booker and Senator Rubio for their leadership on addressing stillbirth.”
