## A BILL

To reauthorize the Second Chance Act of 2007.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Second Chance Reau-  
5       thorization Act of 2024”.

6       **SEC. 2. IMPROVEMENTS TO EXISTING PROGRAMS.**

7       (a) STATE AND LOCAL REENTRY DEMONSTRATION  
8       PROJECTS.—Section 2976 of title I of the Omnibus Crime  
9       Control and Safe Streets Act of 1968 (34 U.S.C. 10631)  
10      is amended—

11               (1) in subsection (b)—

1 (A) in paragraph (7), by striking “and” at  
2 the end;

3 (B) in paragraph (8), by striking the pe-  
4 riod at the end; and

5 (C) by adding at the end the following:

6 “(9) treating substance use disorders, including  
7 by providing peer recovery services, case manage-  
8 ment, and access to overdose education and overdose  
9 reversal medications; and

10 “(10) providing reentry housing services.”; and

11 (2) in subsection (o)(1), by striking “2019  
12 through 2023” and inserting “2025 through 2029”.

13 (b) GRANTS FOR FAMILY-BASED SUBSTANCE ABUSE  
14 TREATMENT.—Section 2926(a) of the Omnibus Crime  
15 Control and Safe Streets Act of 1968 (34 U.S.C.  
16 10595a(a)) is amended by striking “2019 through 2023”  
17 and inserting “2025 through 2029”.

18 (c) GRANT PROGRAM TO EVALUATE AND IMPROVE  
19 EDUCATIONAL METHODS AT PRISONS, JAILS, AND JUVE-  
20 NILE FACILITIES.—Section 1001(a)(28) of the Omnibus  
21 Crime Control and Safe Streets Act of 1968 (34 U.S.C.  
22 10261(a)(28)) is amended by striking “2019, 2020, 2021,  
23 2022, and 2023” and inserting “2025 through 2029”.

24 (d) CAREERS TRAINING DEMONSTRATION  
25 GRANTS.—Section 115(f) of the Second Chance Act of

1 2007 (34 U.S.C. 60511(f)) is amended by striking “2019,  
2 2020, 2021, 2022, and 2023” and inserting “2025  
3 through 2029”.

4 (e) OFFENDER REENTRY SUBSTANCE ABUSE AND  
5 CRIMINAL JUSTICE COLLABORATION PROGRAM.—Section  
6 201(f)(1) of the Second Chance Act of 2007 (34 U.S.C.  
7 60521(f)(1)) is amended by striking “2019 through 2023”  
8 and inserting “2025 through 2029”.

9 (f) COMMUNITY-BASED MENTORING AND TRANSI-  
10 TIONAL SERVICE GRANTS TO NONPROFIT ORGANIZA-  
11 TIONS.—Section 211(f) of the Second Chance Act of 2007  
12 (34 U.S.C. 60531(f)) is amended by striking “2019  
13 through 2023” and inserting “2025 through 2029”.
